FALL LUNCHEON: Thursday, October 11, 2018 at Saint Thomas Episcopal Church, Bath, NY Meal will be catered by church members with a slide presentation about the stain glass windows at First Presbyterian Church. After the presentation, members may go to the Presbyterian church for a walking tour.

Legislative Report:

<u>State Priorities:</u> ** Minimum Pension Bump up: This bill would extend the minimum retirement allowance provided to long standing retired members of the NYSRTS who retired prior to July 1, 1980 and increase the minimum retirement allowance for all such retirees to \$550 per year of NYS service up to a maximum of \$19,250.

** Improve Pension COLA: NYSRTA supports making improvements to COLA legislation by raising the base benefit amount upon which the COLA is computed from \$18,000 to \$25,000.

**For Ethics Reform: The is talk of term limit bills for Senate and Assembly seats(this would take action for two years and a constitutional referendum) and talks of term limits of legislative leaderships(this could be done with bills passed in legislation). Seeking info from Legislators on their feelings on these issues.

**New York Health Act: NYSRTA has no official position on this legislation but are asking questions like, "How will passage of this Act affect our retirees?" Seeking feedback from legislators of why or why not support this.

<u>Federal Priorities</u> ** Negotiation of Covered Medicare Part D Covered Drugs: Allow the Secretary of Health and Human Services to negotiate covered Part D drug prices for Medicare Beneficiaries.

** Strengthening Social Security and Medicare Trust Fund: Support and increase to the average beneficiary of \$800 per year. Change the cost-of-living calculations to reflect the living expenses of Social Security Beneficiaries. NYSRTA opposes any cuts to Medicare benefits.

** Observation vs. Impatient for coverage under Medicare: To amend title XVIII of the Social Security Act to stabilize and modernize the provisions of hospitalization services under the Medicare program. Although a **federal law was passed requiring notificatio**n it **has not been** uniformly applied by hospitals and patients are **STILL** being surprised by having been listed **under observation**. Patients are faced with excessive charges that **should have been covered by Medicare** and learn that entry into rehabilitation is denied as Medicare will not pay **due to observation status**.

** School Safety: School facilities are requesting more funding to better the security on the campuses: more police officers on grounds, alarm detectors, bullet proof doors, training.
